Marshals wishing to authorise people must wait until you have received your authorisation card before you can authorise anyone, otherwise their paperwork will be refused.

Where did the waiver go?

Providing some information is optional, but if you choose not to provide your name and contact details, we'll be unable to provide you with an authorisation card, and you will be unable to participate in activities which require authorisation.

Your information is held in the Authorisations database that is maintained by the Lochac Masonry team, and can be accessed by approved marshals and lists officers in New Zealand and Australia.
